Who will be selected to participate in SIS interviews?

DODD will identify 700 individuals with DD who have significant support needs, including people on an IO waiver with annual support costs of \$130,000 or more; new admissions to Developmental Centers; and residents of mental health hospitals. In addition, DODD will assess a random sample of another 700 individuals, for comparison profiles across varying levels of support needs.

Will participating in a SIS interview/evaluation affect my current funding?

No. Information collected will not in any way be used to make decisions about any individual's funding for services.

Am I required to participate in a SIS interview if invited or requested?

No. You can decline. However, we expect most people will support the project if they can because it will help us learn more about our resource needs.

How is the assessment completed?

A face-to-face interview is conducted with the person and at least two other people who know them well, such as a family member, guardian or SSA.

Who will see my assessment report?

You, your legal guardian (if you have one), and DODD.

Continuous Improvement of Quality of Life

DODD is committed to serving its mission of continuous improvement of the quality of life for Ohio's citizens with developmental disabilities and their families. The values that drive that mission include helping to increase the state and local systems' capacity for supporting individuals and families, providing leadership that supports self-determination principles, and continuing to be a good steward of limited resources. Ohio's DD support system serves our citizens best when fostering independence, full integration into society and choices in care and settings. Together, we inspire possibilities by measuring the supports a person needs to live a successful life.

Focusing on Support Needs: Evaluating the Long-Term Benefits of the SIS Scale

To support community-living options and long-term sustainability in providing supports for individuals with significant needs, DODD is conducting a Support Intensity Scale (SIS) Project. The project will provide Ohio with first-hand experience in using the SIS assessment in order to determine the effectiveness and benefit of the information it provides. Our goal is to determine if this tool provides the best information needed to make data-driven decisions about how to use resources most efficiently to serve more people more effectively—by focusing on the supports needed to participate fully in community life.



SIS Project Facts

- ◆ Three-year Evaluation Project
- ◆ Assessing 700 individuals with significant support needs.
- ◆ Assessing a random sample of 700 other individuals with DD, for comparison across settings & support needs.
- ◆ Implementing with trained interviewers.
- ◆ Experienced researchers to evaluate data.

How We will Implement

Specially trained interviewers will personally assess selected volunteers who have significant support needs. After that phase is complete, the assessment specialists will then interview randomly selected volunteers to gather a comparison across settings and levels of support needs.

The interview is a semi-structured conversation, and an opportunity to learn new or additional information about a person's support needs that may be helpful in planning services. While the assessment helps us gather data through interviews and personal interaction—one person at a time—we only measure aggregate data, not per individual.

Project Outcome Goals

The data generated by the SIS Project will be analyzed to identify elements of the service and support environment that correlate with successful and cost-effective services for people with developmental disabilities. The results will inform our system on how to continue to meet the needs of individuals with developmental disabilities who have significant challenges in the most efficient and effective manner. We will have a baseline standard for consistent assessments. By maintaining consistency in what's being measured and how it's rated, our assessments can measure expected intensity of support needed for individuals with similar profiles.
