

SELF WAIVER SUPPORT BROKER TRAINING DATES for the beginning of 2013

Listed below is information regarding the remaining Support Brokerage Trainings that have been established both for potential providers who want become actual Support Brokers (the all-day Support Broker Certification Training), as well as Stakeholders (providers, SSAs, family members, individuals) who want to learn more about the Role of the Support Broker within the SELF Waiver. We will start again with both types of trainings in January and February of 2013 (dates listed below).

- **Support Broker Certification Training**

This is the all-day training that must be completed successfully for someone to provide Support Brokerage (whether on a paid or unpaid basis). The Support Broker Certification Training will be conducted *via webinar* in January and February of 2013 (see additional information below). Please note there are additional training and certification requirements to become a provider of Support Brokerage which can be found in the Support Brokerage rule (OAC 5123:2-9-47). Please also keep in mind that current County Board employees as well as current employees of providers of *other SELF Waiver services* are prohibited from becoming Support Brokers.

- Both the January and February Support Broker Certification Trainings will take place via webinar. Those trainings will be held from **9:30 am – 4:30 pm** on the following dates:

- **Stakeholder trainings on the Role of the Support Broker under DODD's SELF Waiver**

(Please note: this is not the Support Broker training that is required to provide Support Brokerage. For information on those trainings, please see above.)
